Better tax efficiency on returns compared to short term debt funds

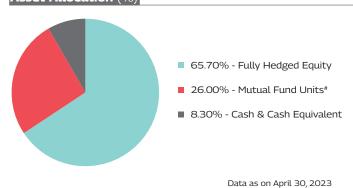
