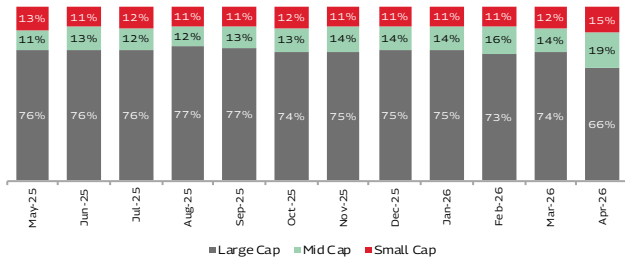

Scheme Strategy

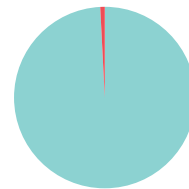
