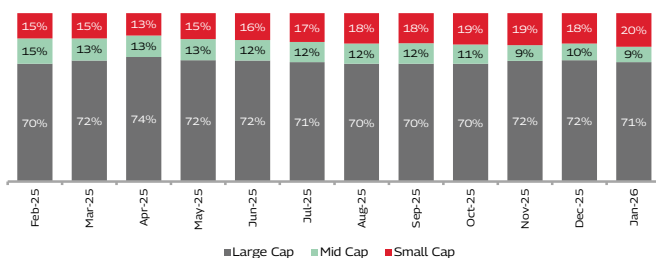


Asset Allocation shall be rebalanced regularly by fund managers based on evolving market dynamics.

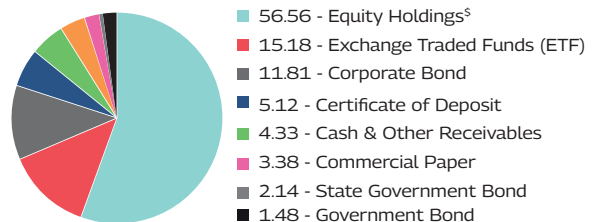
