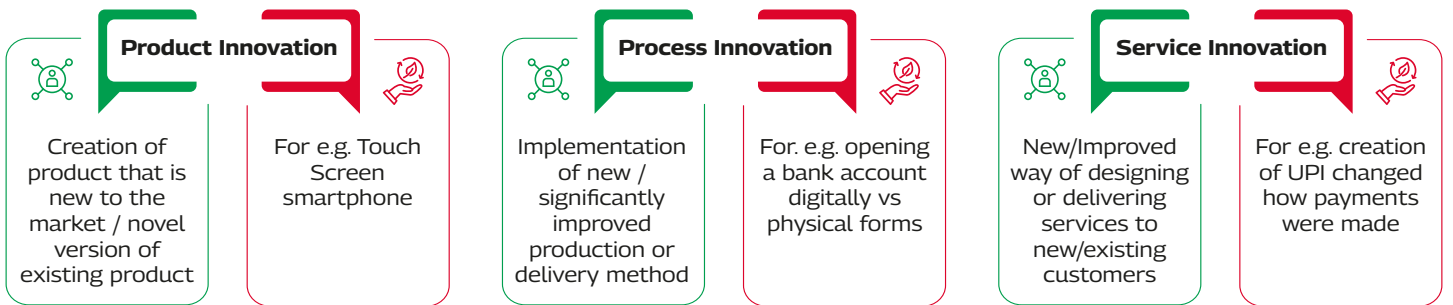

### What is Innovation?

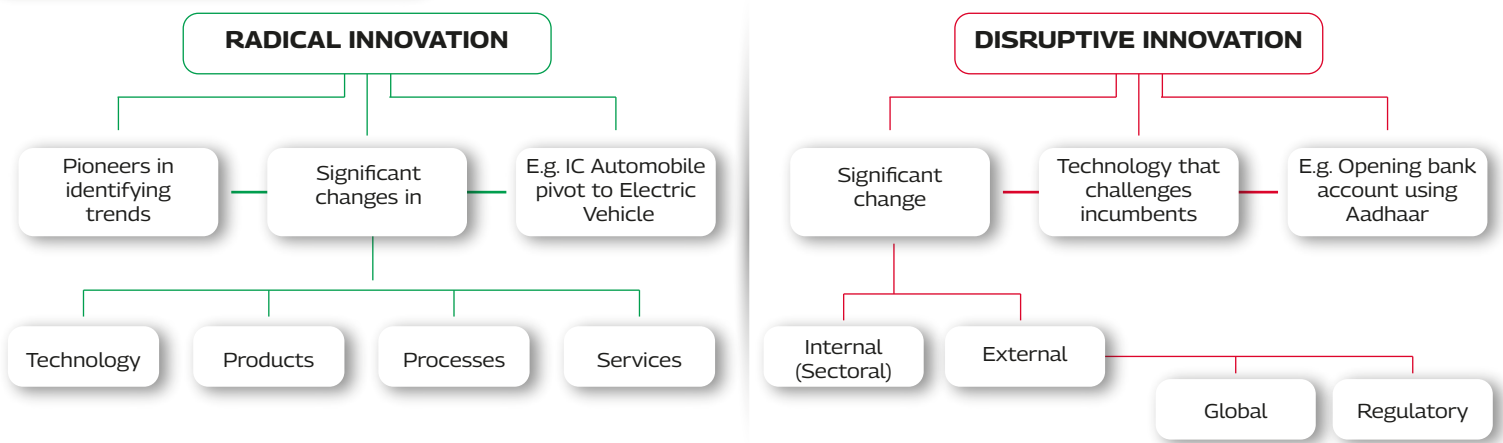

### Type of Innovation

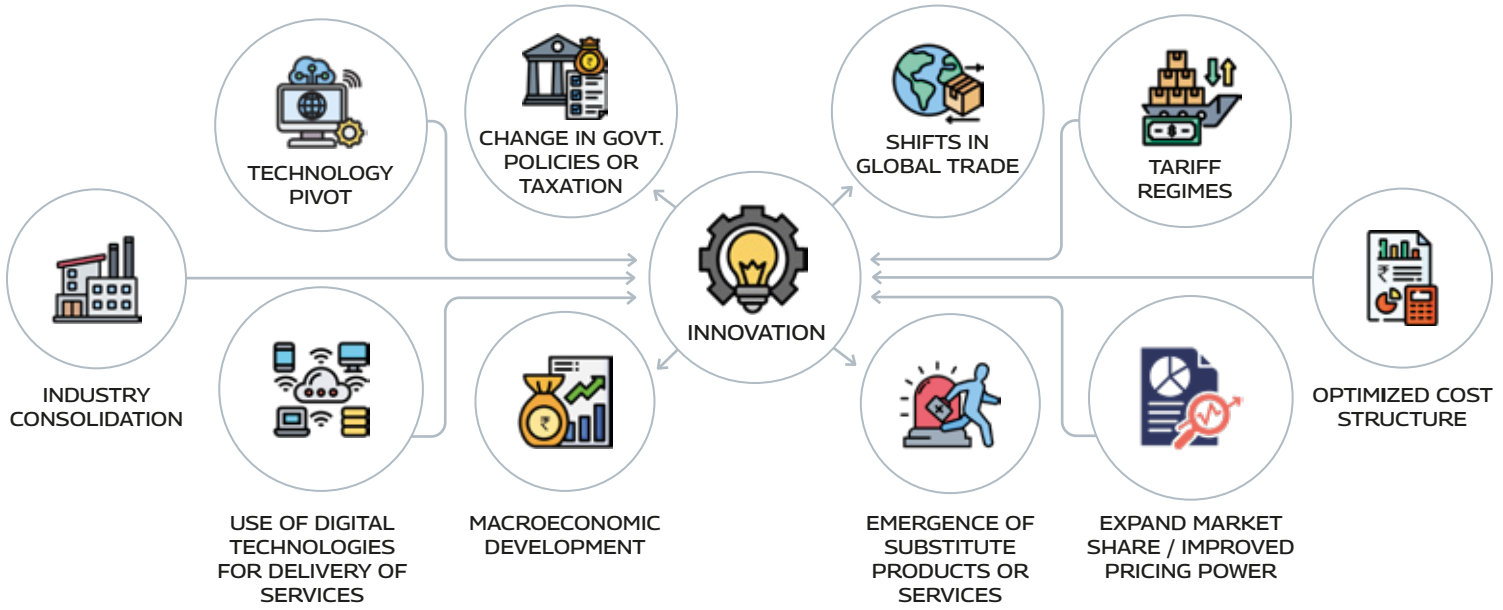
Innovations can be categorized into Product, Process and Service Innovation depending on the key area/technology that is undergoing change.

## Asset Allocation

The Asset Allocation Pattern of the Scheme under normal circumstances would be as under:

The margin money deployed on derivative positions would be included in the Debt and Money Market Securities category.
