These factors may tend to hurt near term profitability and valuations without changing longer term dynamics of the sector.

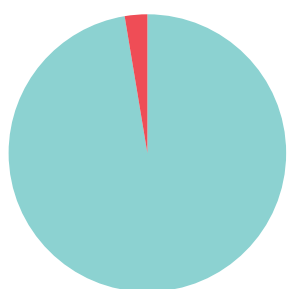


Individual Stocks:
